RESPONSE TO STAFF REPORT AND RECOMMENDATION

COMES NOW Confluence Rivers Utility Operating Company, Inc., ("Confluence Rivers") and for its *Response to Staff Report and Recommendation* states as follows to the Missouri Public Service Commission ("Commission"):

1. On August 26, 2024, Confluence Rivers filed an *Application and Motion for Waiver*

("Application") with the Commission requesting approval of its acquisition of certain water assets of Gascony Water Company, Inc. ("Gascony"); a transfer of Gascony's Certificate of Convenience and Necessity ("CCN"), or a grant of a new CCN, to Confluence Rivers; and, a waiver of the Commission's 60-day notice requirement under 20 CSR 4240-4.017(1).

2. On November 26, 2024, Staff filed its *Report and Recommendation* and supporting *Memorandum* suggesting that the Commission approve Confluence Rivers' Application, subject to the conditions/actions outlined in the Staff *Memorandum* and recommended that the Commission waive the 60-day notice requirement under 20 CSR 4240-4.017(1).

Confluence Rivers has reviewed the proposed conditions/actions listed on pages 9 10 of Staff's *Memorandum* and states that it has no objection to those conditions/actions.

WHEREFORE, Confluence Rivers requests the Commission issue an order approving Confluence Rivers' Application and authorize Gascony to sell and transfer utility assets to Confluence Rivers, grant Confluence Rivers a CCN as recommended in Staff's *Memorandum*, grant a waiver of Rule 20 CSR 4240-4.017(1), and grant such other and further relief as deemed appropriate in the circumstances.
