ORDER DIRECTING FILING

On June 28, 2024,¹ Complainant Keith Edwards filed a complaint with the Commission against Missouri-American Water Company (MAWC). On August 21, MAWC filed its *Answer and Motion to Dismiss*. On October 3, Staff filed its *Staff Report*.

On October 10, the Commission held a prehearing conference in which the parties were asked to collaborate and file a proposed procedural schedule on which all parties agree. On December 3, Staff filed a *Proposed Procedural Schedule*. The procedural schedule did not state whether the parties prefer the evidentiary hearing be virtual or in-person and the location, if so.

Accordingly, the Commission will order the parties to respond with their preferred location or virtual setting for the evidentiary hearing.

THE COMMISSION ORDERS THAT:

1. Any objection to Staff's *Proposed Procedural Schedule* shall be filed no later than December 10, 2024.

2. The parties shall file their preferred location or virtual setting for the evidentiary hearing no later than December 10, 2024.

3. This order shall be effective when issued.
