## ORDER DIRECTING NOTICE, ESTABLISHING INTERVENTION DATE, AND DIRECTING FILING OF STAFF RECOMMENDATION

On December 2, 2024, Evergy Metro filed a tariff, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism Rider. Commission Rule 20 CSR 4240-20.093(4) requires the Commission’s Staff to examine and analyze the information Evergy Metro has filed and to submit a recommendation no later than 30 days after Evergy Metro filed its tariff revision. Because that 30<sup>th</sup> day falls on a New Year’s Day, Staff’s recommendation will be due no later than Monday, January 2, 2025.

The Commission will establish a deadline for any other entity that may wish to apply to intervene and will direct its Data Center to serve a copy of this order upon the parties in EO-2023-0369 and upon the county commission of each county in Evergy Metro’s service area. In addition, the Commission’s Public Policy and Outreach Department shall make notice of this order available to the media serving Evergy Metro’s service area.

### THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall add all parties from File No. EO-2023-0369 to the service list for this case.

2. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the service territory of Evergy Metro.

3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the news media serving the residents of the service territory of Evergy Metro.

4. Any proper person or entity wishing to intervene in this matter shall file an application to intervene no later than December 18, 2024.

5. The Staff of the Commission shall file its recommendation no later than January 2, 2025.

6. This order shall be effective when issued.
