**REQUEST FOR ADDITIONAL TIME TO RESPOND**

COMES NOW Spire Missouri Inc. (“Spire Missouri” or the “Company”), and respectfully submits this *Request for Additional Time to Respond*, stating the following:

1. On October 16, 2023, Staff of the Missouri Public Service Commission filed a motion to establish a case and open an investigation into a natural gas incident in Holt, Missouri.
2. On October 25, 2023, the Missouri Public Service Commission (“Commission”) granted Staff’s request and issued an order opening an investigation.
3. Staff of the Commission (“Staff”) conducted its investigation, issuing numerous data requests to the Company, before filing its Incident Report on November 27, 2024, over a year after the docket had been opened.
4. Spire Missouri will take its opportunity to respond to the Staff Incident Report. Generally, there is a 10-day response time, however, due to the length of the investigation and report, Spire Missouri requests additional time, until January 10, 2025, to file its response.
5. Staff has been advised of this request and does not object.

**WHEREFORE**, Spire Missouri respectfully requests the Commission grant Spire Missouri’s request to file its response to Staff’s Incident Report on or before January 10, 2025, and order any other relief as is just and reasonable.
