ORDER DIRECTING RESPONSES TO COMPLIANCE TARIFF

On November 21, 2024,¹ the Commission issued its *Order Approving Stipulation and Agreement* (Order) in the matter of a small utility rate case for Vicinity Energy Kansas City, Inc. (Vicinity) On December 3, Vicinity filed tariff sheets purporting to be in compliance with the Commission's Order. The tariff sheets, assigned Tracking No. JH-2025-0087, have an effective date of January 1, 2025.

The Commission will direct the Staff of the Commission (Staff) to review the tariff sheets and provide its recommendation. The Commission will also set a time for other responses.

THE COMMISSION ORDERS THAT:

1. No later than December 19, 2024, Staff shall file a recommendation regarding the compliance tariff sheets or a statement of when it expects to file its recommendation.
2. Any other party that wishes to respond to the compliance tariff sheets shall do so no later than December 19, 2024.

3. This order shall be effective when issued.
