
#### A. General

 One Directory listing is furnished without charge to each customer in conformity to the Company's practices. Listings are intended primarily for the purpose of identification and are limited to information that is essential to such identification. (T)

#### **B.** Conditions

- 1. A Primary Listing is furnished as part of and in the rates for telephone service. The Primary Listing may include the name, address and telephone number of:
  - a. The individual, organization, firm or corporation contracting for the service.

## **B.** Conditions (Continued)

- 2. An Additional Listing may also include the same address and telephone number as the Primary Listing, except that a different address may be shown for off-premises stations located on other premises occupied solely by the customer.
  - a. Additional Listings may be furnished with business service for persons who (T) occupy the same premises.

- 3. A Foreign Listing is a listing in any directory for which the customer does not (T) have local service. The rate for a Foreign Listing will be the rate listed in the tariff.
- 4. Line of Information (charged as an Additional Listing) is listed information in (T) addition to a primary or extra listing that is intended to supply additional or special instructions to the calling parties, e.g., office hours.
