**STAFF RECOMMENDATION TO APPROVE TARIFF**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its recommendation that the Commission approve the tariff sheets filed by United Services, Inc., states the following:

1. On November 19, 2024, the parties filed a unanimous disposition agreement resolving all issues.
2. On November 20, 2024, TBJ Sewer Systems, Inc. (“TBJ”) filed a tariff to comply with the pending disposition agreement. The tariff was assigned Tracking No. JS-2025-0074 and carries an effective date of January 3, 2025.
3. On December 3, 2024, TBJ filed a substitute tariff to address an issue found by Staff.
4. On November 21, 2024, the Commission issued its *Order Directing Responses to Compliance Tariff*. The *Order* directed Staff to file a recommendation as to whether the tariff complies with the disposition agreement no later December 4, 2024.
5. Staff has reviewed the tariff and found that it complies with the disposition agreement and recommends that it be approved with the pending disposition agreement.

**WHEREFORE**, Staff respectfully submits this Staff Recommendation to Approve Tariff, and respectfully requests the Commission approve the tariff filed by TBJ and pending unanimous disposition agreement.


