ORDER EXTENDING TIME TO RESPOND

On November 27, 2024, Staff of the Commission (Staff) filed its investigative report. Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless another response time is established by the Commission. Spire Missouri Inc. d/b/a Spire's response is due December 9, 2024.

On December 4, 2024, Spire filed a *Request for Additional Time to Respond*. The *Request* explains that due to the length of Staff's investigation and report, Spire requests an extension for the filing of Spire's Response to January 10, 2025.

The Commission finds this request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Spire's request for an extension is granted.
2. Spire's response to Staff's investigative report shall be filed no later than January 10, 2025.

3. This order shall be effective when issued.

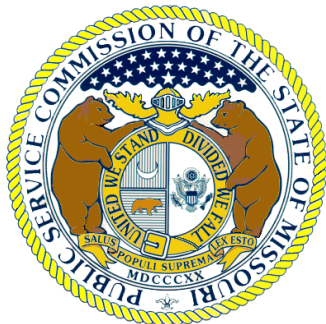
