On December 4, 2024, Spire Missouri Inc. d/b/a Spire filed a status report which included a request for an extension of time to file a further status report or settlement agreement by January 10, 2025. Spire indicated the agreement of the Staff of the Commission and the City of Kansas City to the request.

The Commission finds the request reasonable and will grant it.

1. The parties shall file a status report, a settlement agreement, or a request for an extension of time no later than January 10, 2025.
