STAFF’S COMPLIANCE TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”) and makes the following recommendation on Ameren Missouri’s¹ revised tariff sheet with the assigned Tracking No. JE-2025-0076.

On October 30, 2024,² the Commission issued a *Report and Order Approving Addendum to Territorial Agreement* (“Order”) in this matter. Among other things, that Order directed Ameren Missouri to submit revised tariff sheets to reflect the change in its certificated electric service area in Cooper County resulting from the order. On November 21, Ameren Missouri filed a tariff sheet bearing an effective date of January 2, 2025. On December 2, Ameren Missouri filed a substitute revised tariff. The tracking number for the revised tariff is JE-2024-0076. The Commission has ordered a Staff Recommendation on the revised tariff, same to be filed no later than December 6.

The Staff has reviewed the revised tariff, the associated company filings, and the Commission’s Order. The Order required Ameren Missouri to file a revised tariff sheet setting out a map and/or legal description reflecting Ameren Missouri’s territorial boundaries per the amendment to a territorial agreement. The Order also approved that amendment, which the Commission identified as *Second Amendment to the Territorial*

Agreement Between Union Electric Company d/b/a Ameren Missouri
(Attachment 1 of *Joint Application to Amend Territorial Agreement*, filed September 13, 2024). Staff's Memorandum, attached hereto as Appendix A, describes its review of the revised tariff and accompanying legal description and maps which Ameren Missouri filed. As explained in its Memorandum, Staff concludes that although per Commission practice, with regards to Ameren Missouri's tariffs, the legal description and map will not be contained in the revised tariff sheets in the Commission records, nevertheless the revised Tariff JE-2024-0074 does include a reference to the case file setting out where the map can be found in the Commission's records. Accordingly, Staff recommends that the Commission approve the following Revised Tariff JE-2024-0076 with an effective date of January 2, 2025:

STAFF RECOMMENDATION

On November 21, 2024, Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) filed with the Missouri Public Service Commission (“Commission”) a revised tariff sheet (Schedule 6 – Schedule of Rates for Electricity, Sheet No. 14)¹, that is proposed to become effective on or after January 2, 2025. This revised tariff sheet reflects the changes to its Missouri electric service area as a result of Addendum No. 2 to its Territorial Agreement (“TA”) with Co-Mo Electric Cooperative Inc., which was approved by the Commission’s *Report and Order Approving Addendum to Territorial Agreement (“Report and Order”)* issued October 30, 2024, with an effective date of November 9, 2024. The Staff of the Missouri Public Service Commission (“Staff”) has reviewed the proposed tariff sheet. It was filed to comply with the Commission’s *Report and Order* in EO-2025-0092, which required Ameren Missouri to file such compliance tariffs.

Staff has reviewed the filings and notes that Ameren Missouri filed a document along with its revised tariff submittal that contains a map with the approximate location of 1915 Tisdale Drive, Boonville, Missouri, the Murphy property, which is the subject of the Second Amendment to the Territorial Agreement. However, per the practice of the Commission, with respect to Ameren Missouri's tariffs, the map and/or legal description which Ameren Missouri filed will not be actually included with the filed revised tariff. Ameren Missouri's tariffs which concern territorial agreements ordinarily include a provision that describes the changes in the service territory which have been effected by the territorial agreement along with the associated case numbers. Ameren Missouri's substitute tariff, filed on December 2, 2024, contains such a provision. Staff has reviewed the provision and finds that in this case, Ameren Missouri's substitute tariff conforms with its standard practices, as previously approved by the Commission. Staff recommends the Commission issue an Order approving the following proposed revised "Substitute Tariff" sheet, as filed on December 2, 2024:

Ameren Missouri is current regarding its Assessments and in filing its annual reports. Staff is not aware of any other matter pending before the Commission that affects or is affect by the filing of this tariff revision. Staff notes that Ameren Missouri has an active case currently before the Commission requesting an increase in its electric rates.


