On November 8, 2024,<sup>1</sup> the Commission ordered that any party wishing to respond to Liberty's proposed test year shall do so no later than December 5.

On December 5, the Staff of Commission (Staff) filed a request for an extension of time to file its response to the test year until December 9. Staff stated that it and The Empire District Electric Company d/b/a Liberty are currently engaging in ongoing discussions about Staff's concerns in this case. Staff stated it needs additional time to assess whether it has material data needed to conduct its review in support of its direct case.

The Commission finds Staff's request for an extension reasonable and will grant an extension of time to all parties.

1. Staff's request for an extension of time is granted.
