## ORDER GRANTING EXTENSION

On November 8, 2024,<sup>1</sup> Missouri-American Water Company (MAWC) submitted an application requesting authorization to issue long-term debt in the amount up to \$525.0 million.

The Staff of Commission (Staff) was directed to file a recommendation no later than December 5. On December 5, Staff filed a request for an extension of 30 days, as it is in the process of reviewing the data request responses it received from MAWC on December 3. Staff stated it anticipates it will need to send follow-up data requests.

The Commission finds Staff's request for an extension reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time is granted. Staff shall file a recommendation regarding MAWC's application no later than January 7, 2025.
2. This order is effective when issued.
