ORDER APPROVING TARIFF

Issue Date: December 10, 2024 Effective Date: December 21, 2024

On June 6, 2024, Spire Missouri Inc. (Spire) filed an application seeking permission and approval and a certificate of convenience and necessity (CCN) to construct, install, own, operate, maintain, and otherwise control and manage natural gas distribution systems throughout the state of Missouri and for approval to acquire natural gas assets of Southern Star Central Gas Pipeline, Inc. On November 21, 2024, the Commission issued an Order granting the application.

On November 21, 2024, Spire filed a *Motion for Expedited Treatment* along with a tariff sheet to implement the order. That tariff bears an effective date of December 21, 2024. The *Motion for Expedited Treatment* asks the Commission to approve the tariff to become effective no later than December 6, 2024. On November 22, 2024 the Commission issued an Order directed Staff to file an expedited recommendation and all other responses to be filed no later than December 2, 2024. On December 2, 2024 Staff filed a recommendation saying the Commission should approve the tariff, but the request for expedited treatment should be denied. No other responses were filed.

Under 393.140(11) a request for expedited treatment is allowable but permissive. In *State ex rel. Office Of Public Counsel v. Public Service Commission of the State Of Missouri*, 409 S.W. 3rd 522 (2013) requests to expedite treatment are presumptively unreasonable when they are less than thirty days. The request to expedite contains no reason to substantially overcome the unreasonable presumption. In addition, granting a *Motion for Expedited Treatment* would not allow interested parties a meaningful time to file objections. The Commission will follow the Staff recommendation and deny the *Motion for Expedited Treatment*. The tariffs will go into effect on their originally scheduled date.

THE COMMISSION ORDERS THAT:

- 1. The Commission shall deny the *Motion for Expedited Treatment*.
- 2. Spire's tariff filing, assigned Tariff Tracking No. JG-2025-0077, is approved to be effective December 21, 2024, The tariff sheets approved are:
