

DZTM Project

Zachary to Maywood Segment

A 150-foot-wide easement, the centerline described as follows:

Part of Sections 29, 28, 27, 34, 35, and 36 in Township 62 North, Range 15 West; and part of Section 01 in Township 61 North, Range 15 West; and part of Sections 06, 05, 04, 03, 10, 11, and 12 in Township 61 North, Range 14 West; and part of Sections 7, 8, 17, and 16 in Township 61 North, Range 13 West all falling within the fifth Principal Meridian, Adair County, Missouri. Also, part of Sections 16, 15, 14, and 13 in Township 61 North, Range 13 West; and part of Sections 18, 19, 20, 21, 22, 23, 26, and 25 in Township 61 North, Range 12 West; and part of Sections 30, 29, 32, 33, and 34 in Township 61 North, Range 11 West; and part of Sections 03, 02, 01, 11, and 12 in Township 60 North, Range 11 West; and part of Sections 07, 08, 17, 16, 15, 22, 23, and 24 in Township 60 North, Range 10 West all falling within the fifth Principal Meridian, Knox County, Missouri. Also, part of Sections 19, 30, 29, 28, 27, 34, 35, and 36, in Township 60 North, Range 09 West falling within the fifth Principal Meridian, Lewis County, Missouri. Also, part of Sections 06, 05, 04, 03, 10, 11, and 12 in Township 59 North, Range 08 West; and part of Sections 07, 08, 17, 16, 15, 22, 23, 24, and 25 in Township 59 North, Range 07 West; and part of sections 30 and 31 in Township 59 North, Range 06 West; and part of Sections 06, 05, and 08 in Township 58 North, Range 06 West all falling within the fifth Principal Meridian, Marion County, Missouri.

Beginning in the Northeast Quarter of Section 29, Township 62 North, Range 15 West, at the Zachary Substation, thence east 160 ft, thence south approximately 825 ft to a point, thence east crossing the South Half of the Northeast Quarter of Section 29 to a point 120 ft east of the 1st Trail Rd and 850 ft north of the State Highway 11 in the West Half of the Northwest Quarter of Section 28, thence in a southeasterly direction to the Southeast Corner of the West Half of the Southeast Quarter of Section 28, thence in a southeasterly direction to a point 460 ft west of Burk Trail and 215 ft south of State Highway 11, thence to a point 530 ft south of State Highway 11 and 350 ft west of US Highway 63 both points in the Northeast Quarter of the Southeast Quarter of Section 28, thence to a point approximately 600 ft west of Dogwood Ln and 220 ft south of US Highway 63 in the Southwest Quarter of the Southwest Quarter of Section 27, thence in a southeast direction a point 2,000 ft east of US Highway 63 and 1,600 ft south of Eagle Ln in the Southeast Quarter of the Northwest Quarter of Section 34, thence in a southeast direction across the East Half of Section 34, South Half of Sections 35 and 36, Township 62 North, Range 15 West, Adair County, Missouri; thence in a southeast direction across the Northeast Quarter of Northeast Quarter of Section 01, Township 61 North, Range 15 West; thence in a southeast direction across the North Half of Section 06, Township 61 North, Range 14 West, the Northwest and Southeast Quarters of Section 05, the South Half of Section 04, the Southwest Quarter of the Southwest Quarter of Section 03, the north half of Section 10 to a point 100 ft west of Banner Ln and 1,150 ft south of State Highway F in the Northeast Quarter of Section 10, thence in a southeast direction across the North Half of Section 11, the Northwest and the Southeast Quarters of Section 12, Township 61 North, Range 14 West, Adair County, Missouri; thence continuing in a southeast direction across the South Half of Section 07, Township 61 North, Range 13 West, thence in a southeast direction across the South Half of Section 08 to a point 400 ft north of Salt River Lane in the Southwest Quarter of the Southeast Quarter of Section 08, thence in a southeast direction across the Northeast Quarter of the Northeast Quarter of Section 17, and the North Half of Section 16, Township 61 North, Range 13 West all falling within the fifth Principal Meridian, Adair County, Missouri.

Thence continuing in a southeast direction to a point approximately 1,500 ft south of County Road 242 and approximately 700 ft east of the West boundary line of Section 15, Township 61 North, Range 13 West, Knox County, Missouri, thence in a southeast direction across the remaining North Half of Section 15, South Half of Section 14, and the South Half of Section 13 to a point 550 ft north of County Road 247 and 1,550 ft east of State Highway A in the Southeast Quarter of the Southeast Quarter of Section 13, thence in a southeast direction across the remaining portion of the Southeast Quarter of Section 13, Township 61 North, Range 13 West, Knox County, Missouri; thence in a southeast direction across the Southwest Quarter of Section 18, Township 61 North, Range 12 West, Knox County, Missouri, the North Half of Section 19 to a point 40 ft east of State Highway A and 1,300 ft south State Highway F, thence to a point 750 ft east of State Highway A and 1,550 ft south State Highway F, both points located in the West Half of the Northwest Quarter of Section 20, thence to a point 2,000 ft south of State Highway F in the East boundary line of the Northwest Quarter of Section 20, thence in a southeast direction across the East Half of Section 20, South Half of Section 21, the South Half of Section 22 to a point 815 ft west of County Road 222 and 1,230 ft north of County Road 252 in the East Half of the Southwest Quarter of Section 22, thence in the southeast direction across the South Half of the Southeast Quarter of Section 22, the West Half the Southwest Quarter of Section 23, and the North Half of Section 26, the North Half of Section 25 to a point 1,200 ft west of State Highway 15 and approximately 450 ft north of the South boundary line of the Northeast Quarter of Section 25, thence in a southeast direction across the remaining portion of the Southeast Quarter of Section 25, Township 61 North, Range 12 West, Knox County, Missouri; thence continuing in a southeast direction to a point 180 ft west of State Highway 15 and 120 ft south of County Road 286 in Section 30, Township 61 North, Range 11 West, thence East approximately 685 ft to a point, thence in a southeast direction across the remaining South Half of Section 30, the West Half of the Southwest Quarter of Section 29, the North Half of Section 32, the West Half of the Northwest and the South Half of Section 33, and the West Half of the Southwest Quarter of Section 34, Township 61 North, Range 11 West, Knox County, Missouri; thence continuing in a southeast direction across the North Half of Section 03, Township 60 North, Range 11 West, the South Half of Section 02, and the North Half of Section 12, Township 60 North, Range 11 West, Knox County, Missouri; thence in a southeast direction across Section 07, Township 60 North, Range 10 West, the Southwest Quarter of Section 08, the North Half of Section 17, the Northwest Quarter and the South Half of Section 16, the Southwest Quarter of Section 15, the Northeast Quarter of Section 22 to a point 950 ft north and 1,150 ft west of State Highway 156 in the Northeast Quarter of the Northeast Quarter of Section 22, thence to a point 60 ft west of State Highway 63 and approximately 200 ft south of the North boundary line of the South Half of the Northwest Quarter of Section 23, thence east 510 ft to a point, thence in a southeast direction across the remaining Section 23, the South Half of Section 24, Township 60 North, Range 10 West all falling within the fifth Principal Meridian, Knox County, Missouri.

Thence continuing in a southeast direction across the Southwest Quarter of Section 19, Township 60 North, Range 09 West, Lewis County, Missouri, thence continuing in a southeast direction across the North Half of Section 30, the North Half and the Southeast Quarter of Section 29, the South Half of Section 28, the Southwest of Section 27, the North Half of Section 34, the North Half and the Southeast Quarter of Section 35, the South Half of Section 36 to a point 50 ft east of State Highway D and 2,200 ft north of 310 St in the Southwest Quarter of Section 36, thence in a southeast direction across the remaining South Half of Section 36, Township 60 North, Range 09 West; thence in a southeast direction across the Southwest Quarter of Section 31, Township 60 North, Range 08 West all falling within the fifth Principal Meridian, Lewis County, Missouri.

Thence following the previous Southeast direction across the North Half of Section 06, Township 59 North, Range 08 West, Marion County, Missouri, to a point 1,400 ft north of Highway D and 1,500 ft

west of County Road 105 in the Northwest Quarter of Section 05, thence in a southeast direction across the remaining portion of Section 5, the South Half of Sections 4 and 3, the Northeast Quarter of Section 10, the North Half of Section 11, the Northwest Quarter and the South Half of Section 12, Township 59 North, Range 08 West, Marion County, Missouri; thence following the previous southeast direction to a point approximately 1,200 ft west of County Road 129 and 600 ft north of the South boundary line of Section 07 in the Southeast Quarter of Section 07, thence in a southeast direction across the remaining southeast Quarter of Section 07, Township 59 North, Range 07 West; thence in a southeast direction to a point 370 ft north of County Road 110 and 630 ft west of County Road 129, thence in a southeast direction to a point 90 ft north of County Road 110 and 350 ft west of the East boundary line of the West Half of the Northwest Quarter of Section 17, thence to a point 620 ft south of County Road 110 and 100 ft west of County Road 135 in the Northeast Quarter of the Northwest Quarter of Section 17, thence in a southeast direction across the North Half of Section 17, the Northwest Quarter and the South Half of Section 16, the South Half of Section 15, the Northeast Quarter of Section 22, the North Half of Section 23, and the South Half of Section 24 to a point 70 ft west of Highway A and approximately 1,300 ft north of the South boundary line of Section 24, thence East 1,105 ft to a point, thence south across the remaining Southeast Quarter of Section 24, continuing South in the East Half of Section 25 to a point 100 ft south of Highway M and approximately 300 ft west of the East boundary line of Section 25, thence in a southeast direction across the Southeast Quarter of Section 25, Township 59 North, Range 07 West, Marion County, Missouri; thence in a southeast direction across the Southwest Quarter of Section 30, Township 59 North, Range 06 West, the West Half and Southeast Quarter of Section 31, the East Half of Section 06, the Southwest Quarter of Section 5 to a point 100 ft south of County Road 320 and approximately 770 ft east of the West boundary line of Section 8, thence in a Southeasterly direction to a point approximately 2,500 ft south of County Road 320 and 1,250 ft east of the West boundary line of Section 08, thence east 654 ft, thence south 300 ft to Maywood Substation, in the Southwest Quarter of Section 08, Township 59 North, Range 06 West all falling within the fifth Principal Meridian, Marion County, Missouri.
