## Zachary to Thomas Hill Segment

A 150-foot-wide easement, the centerline described as follows:

Part of Sections 29, 30, and 31 in Township 62 North, Range 15 West; and part of Sections 06, 07, 18, 19, 30, 31, and 32 in Township 61 North, Range 15 West all falling within the fifth Principal Meridian, Adair County, Missouri. Also, part of Sections 06, 07, 18, 19, 30, and 31 in Township 60 North, Range 15 West; and part of Sections 06, 07, 18, 19, 30, and 31 in Township 59 North, Range 15 West; and part of Sections 06, 07, 18, 19, 30, and 31 in Township 59 North, Range 15 West; and part of Sections 06, 07, 18, 19, and 30 in Township 58 North, Range 15 West; and part of Sections 25, 36, and 35 in Township 58 North, Range 16 West; and part of Sections 02, 11, 14, 23, 26, and 35 in Township 57 North, Range 16 West; and part of Sections 02, 11, 14, 23, 26, and 35 in Township 56 North, Range 16 West all falling within the fifth Principal Meridian, Macon County, Missouri. Also, part of Sections 02, 11, 14, 23, and 24 in Township 55 North, Range 16 West and part of Section 19 in Township 55 North, Range 15 West all falling within the fifth Principal Meridian, Randolph County, Missouri.

Beginning in the Northeast Quarter of Section 29, Township 62 North, Range 15 West, at the Zachary Substation, thence west approximately 345 ft to a point, thence south 1,420 ft to a point, thence west across the North Half of Section 29 to a point 610 ft east of Briar Oaks Trail and 700 ft north of State Highway 11, thence south across the East Half of Sections 30 and 31, Township 62 North, Range 15 West; thence south across the East Half of Sections 06 and 07, Township 61 North, Range 15 West, to a point approximately 1560 ft north of Crest Trail and approximately 680 ft West of the East boundary line of Section 18 in the Northeast Quarter of Section 18, thence in a Southeasterly direction across the East Half of Sections 30 and 31 to a point on the corner of Cedar Hills Trail approximately 30 ft east of the West Boundary line of Section 32, Township 61 North, Range 15 West all falling within the fifth Principal Meridian, Adair County, Missouri.

Thence south across the East Half of Sections 06, 07, 18, 19, 30, and 31, Township 60 North, Range 15 West, Macon County, Missouri; thence south across the East Half of Section 06, Township 59 North, Range 15 West, to a point 375 ft east of State Highway J and approximately 800 ft north of the South boundary line of the North Half of Section 07 said point being located in the Southwest Quarter of the Northeast Quarter of Section 07, thence in a southwest direction across the remaining East Half of Section 7, the East Half of Section 18, the West Half of Section 19 to a point on the south side of Forbes Rd approximately 1,100 ft west of State Highway 3, thence in a southwest direction to a point 650 ft west of State Highway 3 and approximately 1,200 ft south of Forbes Rd, both points located in the Northwest Quarter of Section 30, thence in a southeast direction across the South Half of Section 30, the West Half of Section 31, all in Township 59 North, Range 15 West, Macon County, Missouri. Thence continuing in a southeast direction to a point 100 ft south of Giraffe St and 1,050 ft east of Glacier Ave in the East Half of the Southwest Quarter of Section 06, Township 58 North, Range 15 West. Thence south across remaining Section 06, the West Half of Sections 07 and 18 to a point close to the North boundary line of Section 19 and 110 ft west of Geyser Ave, thence in a southwest direction to a point 130 ft West of State Highway 3 and approximately 330 ft north of the South boundary line of the North Half of the Southwest Quarter of Section 19, thence in a southwest direction across the remaining Southwest Quarter of Section 19, and the Northwest Quarter of Section 30, all in Township 58 North, Range 15 West; thence continuing in a southwest direction across the East Half and the Southwest Quarter of Section 25, Township 58 North, Range 16 West, the West Half of Section 36, and Southeast Quarter of Section 35, Township 58 North, Range 16 West, Macon County, Missouri; thence continuing southwest

across the East Half of Section 02, Township 57 North, Range 16 West, to a point 85 ft south of Fortune St and approximately 400 ft west of the East boundary line of the West Half of Section 02, thence southwesterly across the remaining Southwest Quarter of Section 02, the West Half of Section 11, the West Half of Section 14 to a point 75 ft north of Elder Pl and approximately 1,900 ft East of Fireworks Ave in the Southwest Quarter of Section 14, thence in a southwest direction across the West Half of Sections 23 and 26 to a point 90 ft south of Fallow Pl and approximately 80 ft East of the West boundary line of Section 35, thence south across the West boundary of Section 35, all in Township 57 North, Range 16 West, Macon County, Missouri; thence south across the West boundary of Section 02, Township 56 North, Range 16 West, to a point 90 ft south of Fleetwood St and approximately 2,500 ft West of State Highway 3 in the Northwest Quarter of Section 11, thence in a southeast direction across the West Half of Sections 23 and 26 to a point 90 ft south of Falcon St and 1900 ft west of State Highway 3 in the Northwest Quarter of Section 11, thence in a southeast direction across the West of State Highway 3 in the Northwest Quarter of Section 23, thence south across the West Half of Sections 23 and 26 to a point 60 ft South of Empire Rd and approximately 1,900 ft West of State Highway 3 in the Northwest direction across the West Half of Section 35, Township 56 North, Range 16 West and approximately 1,900 ft West of State Highway 3 in the Northwest Quarter of Section 23, thence in a south across the West Half of Sections 23 and 26 to a point 60 ft South of Empire Rd and approximately 1,900 ft West of State Highway 3 in the Northwest Quarter of Section 35, thence in a southwest direction across the West Half of Section 35, Township 56 North, Range 16 West all falling within the fifth Principal Meridian, Macon County, Missouri.

Thence in a southwest direction across the West Half of Sections 02 and 11, Township 55 North, Range 16 West, Randolph County, Missouri to a point 60 south of County Road 1060 and 1,400 ft east of County Road 1050 in the Northwest Quarter of Section 14, thence in a southeasterly direction across Section 14 to a point 80 ft south of County Road 1050 and 1,700 ft west of N Highway 3 in the Northeast Quarter of Section 23, thence in a southeast direction across the Northeast Quarter of Section 24, continuing in a southeast direction of the Southeast Quarter of Section 24 to a point approximately 200 ft north of the South boundary line of Section 24 and 1,000 ft West of the East boundary line of Section 24, thence east across the remaining Southeast Quarter of Section 24, Township 55 North, Range 16 West; thence east across the Southwest Quarter of Section 19, Township 55 North, Range 15 West, approximately 350 ft to the Thomas Hill Substation all falling within the fifth Principal Meridian, Randolph County, Missouri.
