**STATUS REPORT AND REQUEST FOR ADDITIONAL TIME  
TO FILE STAFF REPORT**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its Status Report and Request for Additional Time to File Staff Report, states as follows:

1. On October 30, 2024, William Gregoric filed a complaint with the Missouri Public Service Commission against Evergy Metro, Inc., d/b/a Evergy Missouri Metro (“Evergy”).

2. On October 31, 2024, the Commission issued its *Order Giving Notice of Case Filing, Directing an Answer and Directing a Staff Investigation* (“Order”). The Order directed Staff to file a report no later than December 16, 2024. The Order also directed Evergy to file an answer no later than December 2, 2024.

3. On November 5, 2024, Staff submitted initial Data Requests (“DRs”) to Evergy and received initial responses from Evergy on November 26, 2024 (“November DRs”).

4. On December 2, 2024, Evergy filed an *Answer, Affirmative Defenses, and Motion to Dismiss* (“Answer”).

5. On December 10, 2024, Staff submitted additional DRs to Evergy, in part based on responses received from the November DRs and the Answer. The responses to the December 10, 2024, DRs are due on or by December 30, 2024.

6. Staff respectfully requests additional time to receive and review responses to its additional DRs and anticipates being able to file its report on or by January 23, 2025.

**WHEREFORE**, Staff respectfully submits this Status Report and Request for Additional Time to File Report and requests the Commission allow Staff to file its Staff Report on or by January 23, 2025, and grant such other and further relief as the Commission considers just and reasonable under the circumstances.
