## ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On December 18, 2019, Fidelity Systems Plus, Inc. filed a letter notifying the Commission that it wished to cancel its certificate of service authority to provide payphone service in the State of Missouri, which the Commission had granted on November 25, 1997, in File No. TA-98-123. The Commission directed its Staff to respond to that notice by January 3, 2020. Staff responded on January 2, by filing a motion asking the Commission to cancel Fidelity Systems Plus, Inc.'s certificate.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 11 days from the issuance of this order to file a motion for hearing.
