- 1. Staff supports the proposed rule of 20 CSR 4240-50.060, published in the Missouri Register dated November 15, 2024. This rule sets forth the filing requirements water utility companies must meet when filing its applications for certificates of convenience and necessity with the Commission. The companies must also meet additional requirements that are set out in 20 CSR 4240-2.060(1). The previous rule located in 20 CSR 4240-3.600 is being rescinded in concert with the newly rewritten rule, which is being moved to Chapter 50, Standards of Service by Water Utilities.
- 2. The proposed rule is submitted to update the standards, requirements and procedures for whenever the sewer utilities apply for a certificate of convenience and necessity with the commission, and to place such in the specific utility location for ease of access and use.
- 3. Staff's reasoning and position on the proposed rule are set forth more fully in the attached Staff Comments, which is incorporated by reference herein.

WHEREFORE, Staff respectfully submits Staff's Comments for the Commission's consideration and supports the proposed rule of 20 CSR 4240-50.060.

Missouri Public Service Commission Staff Comments on the Proposed Rule 20 CSR 4240-50.060 Filing Requirements for Water Utility Applications for Certificates of Convenience and Necessity and Proposed Rescission of 20 CSR 4240-3.600 Filing Requirements for Water Utility Applications for Certificates of Convenience and Necessity

<u>Summary:</u> Staff supports the proposal of Commission Rule 20 CSR 4240-50.060 and rescission of Commission Rule 20 CSR 4240-3.600. Significant revisions were made to the existing rule, 20 CSR 4240-3.600, resulting in the need to rescind the existing rule and propose a new rule under Commission Rule 20 CSR 4240-50 Water Utilities, which is the location the proposed rule, 20 CSR 4240-50.060.

<u>Discussion:</u> New and existing water utilities seeking to serve or increase service area are required to submit an application for Certificates of Convenience and Necessity (CCN). The CCN gives the public utility the right to provide retail water service to an identified geographical area. The process can be difficult for water utilities due to requirements and information necessary to ensure that the water utility will be able to provide safe and adequate service.

The proposed Commission Rule, 20 CSR 4240-50.060 Filing Requirements for Water Utility Applications for Certificates of Convenience and Necessity, which was previously under 20 CSR 4240-3.600 with the same name, was determined necessary to provide more transparency to water utilities seeking a CCN. Important regulatory decisions should be based on high quality information, which is the purpose of the proposed rule as it was developed to benefit both water utilities and Staff with clear requirements. Additionally, the proposed regulation requirements are expected to reduce the amount of time it takes to complete a CCN proceeding by reducing subsequent information requests sent to the water utility.

Based on the information above Staff support the proposed rule 20 CSR 4240-50.060 and proposed rescission of 20 CSR 4240-3.600.
