## ORDER CANCELING REGISTRATION

Issue Date: January 3, 2020

Effective Date: January 13, 2020

On December 4, 2019, CoBridge Telecom, LLC (CoBridge Telecom) filed a letter seeking to cancel CoBridge Telecom's registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the State of Missouri. The Commission granted CoBridge Telecom its IVoIP registration in the State of Missouri in File No. DA-2012-0087.

On December 5, 2019, the Commission issued an order directing Staff to file a recommendation. On December 19, 2019, Staff filed a recommendation in support of the cancellation of CoBridge Telecom's iVoIP registration.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup>

Based on CoBridge Telecom's request and Staff's recommendation, the Commission finds that the IVoIP registration granted to CoBridge Telecom, LLC, shall be canceled.

2. This order shall become effective on January 13, 2020.
3. This case may be closed on January 14, 2020.
