On November 7, 2024, Glenn Stephenson filed a complaint with the Commission against Union Electric Company d/b/a Ameren Missouri. On December 12, 2024, Glenn Stephenson filed a pleading dismissing his complaint stating that he had reached an agreement with Ameren Missouri. Ameren Missouri also filed a motion on December 12, 2024, requesting an extension of time to submit a signed dismissal. Ameren Missouri’s extension request is moot now that a dismissal has been filed.
