1. MIEC is a not-for-profit corporation under Missouri law that represents the interests of industrial customers in matters involving utility issues. Those interests include the interests of large industrial consumers of Spire Missouri Inc. d/b/a Spire. ("Spire").

3. As a representative of the interests of large industrial customers of Spire, the MIEC's interest is different from that of the general public and may be adversely affected by actions taken as a result of the decision in this case.

4. The MIEC does not yet have a position on the issues in this case and reserves the right to take positions on specific issues as this case proceeds. The request for the change in rates

is a complex matter. MIEC needs to have the benefit of discovery and analysis of Spire's evidence and reasoning before it can develop an informed opinion. In the absence of that opportunity, we would be opposed to Spire's request.

WHEREFORE, the MIEC respectfully requests that the Commission grant this Application to Intervene together with any further and/or additional relief the Commission deems just and proper.
