On September 15, 2023, the Staff of the Commission filed the above-styled complaint. On December 11, Staff filed a Motion to Dismiss Complaint. In support thereof, Staff states that a Stipulation in File No. ER-2024-0189 has resolved the issues from this case. Thus, Staff asks the Commission to dismiss this case.

Commission Rule 20 CSR 4240-2.116(1) states that once prepared testimony has been filed, a complainant may only dismiss a complaint by leave of the Commission. The Commission notes that the Stipulation it approved in File No. ER-2024-0189 resolves this complaint. Thus, the Commission will grant leave to Staff to dismiss this complaint.
