On December 12, 2024, the Staff of the Commission (Staff) filed its recommendation and memorandum regarding Summit Natural Gas of Missouri, Inc.'s (SNGMO's) Actual Cost Adjustment filing. Staff expressed some concerns, comments, and recommendations which were set forth in the Billed Revenue, Actual Gas Cost, Reliability Analysis and Gas Supply Planning, and Hedging sections of Staff's memorandum. Staff has requested the Commission order SNGMO to respond within 30 days to Staff's concerns, comments, and recommendations.

The Commission will direct SNGMO to respond to Staff's recommendation and memorandum as requested by Staff.

THE COMMISSION ORDERS THAT:

1. No later than January 15, 2025, SNGMO shall file a response to Staff's recommendation and memorandum.
2. This order shall be effective when issued.
