On November 6, 2024,<sup>1</sup> The Empire District Electric Company d/b/a Liberty (Liberty or "Company") filed tariff sheets designed to increase its gross annual electric revenues. The Commission ordered the parties to submit a proposed procedural schedule.

On December 12, Staff filed a *Joint Proposed Procedural Schedule* (Joint Schedule). The Joint Schedule included a due date that will occur prior to the Commission issuing an order setting the procedural schedule. The Joint Schedule also indicated that agreement of the parties. Therefore, the Commission will order the Company to provide the first update on December 19 as agreed upon in the Joint Schedule.<sup>2</sup>
