**ORDER SETTING PROCEDURAL CONFERENCE**

On November 1, 2024,<sup>1</sup> Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (together, “Evergy”) filed a *Notice of Adding New SPP Charge Types* (Notice) in the above captioned cases. The charges are to be included in Evergy’s Fuel Adjustment Rate (FAR). Evergy stated the Notice was filed pursuant to Commission Rule 20 CSR 4240-20.090(8)(D)1A.

Commission Rule 20 CSR 4240-20.090(8)(D)1C permits any party to challenge a request to include a new charge type, and on November 26, the Office of the Public Counsel (OPC) filed its challenge. OPC noted that the rule does not specify when or in what case the Commission should render its decision regarding the challenge. Thus, OPC requested a procedural conference to determine the appropriate next steps.

The Commission will schedule a procedural conference to discuss next steps with the parties. The presiding officer communicated with counsel via email and will schedule the procedural conference to occur on January 7, 2025. All parties are permitted to attend, but Evergy's and OPC's attendance is required.

**THE COMMISSION ORDERS THAT:**

1. A procedural conference shall be held on January 7, 2025, beginning at 1:30 p.m. Evergy and OPC are required to appear, but any party may attend. The procedural conference shall be held via WebEx, and the meeting information will be emailed to all counsel.
2. This order shall be effective when issued.
