On November 25, 2024,¹ Spire Missouri Inc. d/b/a Spire filed tariff sheets and testimony initiating a rate case to increase its annual water and sewer revenues. Consumers Council of Missouri filed a timely application to intervene. Ten days have elapsed, and no party has objected to the application to intervene.² The application satisfies the requirements of Commission Rule 20 CSR 4240-2.075 and intervention will be granted.

THE COMMISSION ORDERS THAT:

1. Consumer Council of Missouri's application to intervene is granted.
