On October 30, 2024, the Commission issued an Order Setting Procedural Schedule. That order set a Discovery Conference for December 19, 2024.

That order also stated that not less than three business days before each conference, any party that has a discovery concern shall file a brief statement describing that concern. Finally, that order stated that if no party identifies any discovery concerns before the scheduling conference, the presiding officer may cancel that conference.

No party has filed any such statement, and the December 19, 2024, discovery conference is less than three business days away. Thus, the Commission will cancel the discovery conference.
