On November 18, 2024,¹ Aladdin PropCo, LLC and Evergy Metro, Inc. d/b/a Evergy Missouri Metro (together, "Joint Applicants") filed an application requesting a variance from Commission Rule 20 CSR 4240-20.050 regarding individual electric meters.

The Commission ordered a review and recommendation from its Variance Committee, pursuant to Commission Rule 20 CSR 4240-20.050(5)(C)(1), due no later than December 18. On December 17, the Variance Committee filed a request for an extension of 30 days. The Variance Committee explained it needed time to review the data request responses that were due December 16, as well as the potential need to issue additional discovery. The Variance Committee stated it will file its recommendation earlier if possible.

The Commission finds the request for an extension reasonable and will grant it.

- 3. Any other party may file a request for a formal hearing or other response to the Variance Committee's recommendation no later than ten days after the filing of the Variance Committee's recommendation.
