ORDER EXTENDING TIME FOR STAFF RECOMMENDATION

On October 25, 2024, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed an application requesting certificates of convenience and necessity (CCNs) authorizing it to construct, install, own, operate, manage, maintain, and control two solar generating facilities – an approximately 65 megawatt (MW) solar farm to be constructed in Wilson County, Kansas and an approximately 100 MW solar farm to be constructed in Jasper County, Missouri.

On October 30, 2024, the Commission directed its Staff to file a recommendation with regard to the application, or a status report stating when it expected to file a recommendation, by December 16, 2024.

On December 16, 2024, Staff filed its *Status Report* in which it stated that it was awaiting responses to approximately 36 Data Requests submitted to Evergy Missouri West. Accordingly, Staff requests additional time to conduct discovery and draft its recommendation.

The Commission finds Staff's request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. No later than March 17, 2025, Staff shall file a recommendation regarding Everygy Missouri West's application or a status report stating when it expects to file a recommendation.
2. This order shall be effective when issued.
