JOINT RESPONSE TO ORDER

COMES NOW Missouri Public Service Commission Staff (“Staff”) on behalf of itself, the Complainant, Ryan Dooley (“Complainant”), and the Respondent, Union Electric Company d/b/a Ameren Missouri (“Ameren” or “Company”), and for its *Joint Response to Order*, respectfully states as follows:

1. On September 16, 2024, Complainant filed a Formal Complaint with the Missouri Public Service Commission (“Commission”) against Respondent.
2. On October 14, 2024, Respondent filed a *Request for Mediation*. Complainant did not respond.
3. On December 9, 2024, Staff filed its *Staff Report* with the Commission.
4. On December 11, 2024, the Commission issued an *Order Directing Filing of Available Dates for Prehearing Conference*, directing all parties to file the dates they will be available for a prehearing conference to be held via WebEx during January 2025.

5. Staff conferred with Counsel for Ameren as well as Mr. Dooley and compiled mutually available dates and times for all parties.¹ The following dates and times represent the availability of Ameren, Staff, and Mr. Dooley in January 2025:

- January 28: 8:30 a.m. to 1:00 p.m. AND 3:00 p.m. to 5:00 p.m.
- January 29: 8:30 a.m. to 1:00 p.m. AND 3:00 p.m. to 5:00 p.m.
- January 30: 8:30 a.m. to 1:00 p.m. AND 3:00 p.m. to 5:00 p.m.

6. As a special note, Mr. Dooley needs to know the date of the prehearing conference a few days before it takes place in order to take time off from work.

WHEREFORE, the undersigned submits this Joint Response to Order for the Commission's Consideration and further relief as is just and proper.
