**ORDER DIRECTING APPLICANT TO SHOW CAUSE  
WHY HIS APPLICATION FOR A CHANGE OF ELECTRIC SUPPLIER  
SHOULD NOT BE DISMISSED**

On December 2, 2024, the Commission ordered Michael Davis to verify his application by December 12, 2024. Commission Rule 20 CSR 4240-2.060(1)(M) requires that all applications be subscribed and verified by affidavit under oath. Commission Rule 20 CSR 4240-2.060(2) requires that Davis verify his application prior to a Commission decision.

Under Commission Rule 20 CSR 4240-2.116(3), a party may be dismissed from a case for failure to comply with any order issued by the Commission. Michael Davis did not verify his application by December 12, 2024, and has not as of the date of this order.

Commission Rule 20 CSR 4240-2.116(4) provides that the Commission may dismiss a case for good cause after ten days' notice to the parties.

The Commission will not dismiss Michael Davis's change of electric supplier request without giving him an opportunity to explain why his application should not be dismissed. Therefore, the Commission will set a deadline for Michael Davis to file a pleading, if he does not want the Commission to dismiss his request for a change of electric supplier application.

**THE COMMISSION ORDERS THAT:**

1. No later than December 26, 2024, Michael Davis may file any reasons that this case should not be dismissed.
2. This order shall be effective when issued.
