Agreement Regarding Carbon Offset Initiative (Order) authorizing Spire to file tariff sheets

to implement the program that comply with the stipulation and agreement approved in the Order.

On December 17, 2024, Spire filed tariff sheets purporting to comply with the Order. The tariff sheets were assigned Tracking No. JG-2025-0097 and bear an effective date of January 18, 2025.

The Commission will direct its Staff to file a recommendation advising the Commission as to whether the filing complies with the Order.

1. No later than January 3, 2025, Staff shall file a recommendation as to whether the tariff sheets filed by Spire on December 17, 2024, and assigned Tracking No. JG-2025-0097 comply with the Commission's *Order Approving Stipulation and Agreement Regarding Carbon Offset Initiative* issued on July 18, 2024.
