## ORDER APPROVING STIPULATION AND AGREEMENT

Issue Date: October 3, 2013 Effective Date: October 13, 2013

On July 19, 2013, Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") submitted revised Economic Development Rider ("EDR") tariffs to the Commission. KCP&L and GMO sought to freeze current EDR tariffs for its customers currently on an EDR tariff under contract, and establish new EDR tariffs for new or qualified customers. On August 9, 2013, the Office of the Public Counsel ("OPC") filed a motion to suspend the tariffs. The Commission granted OPC's motion. A pre-hearing conference was held and a procedural schedule was issued. Upon request from all the parties, the Commission suspended the procedural schedule and on September 27, KCP&L, GMO, OPC and the Staff of the Commission filed a joint Stipulation and Agreement for the Commission's approval.

The Stipulation and Agreement states that the parties resolved their differences and that KCP&L and GMO will no longer seek approval of the tariff sheets filed with the Commission on July 19, 2013. Included as Attachment A of the Stipulation and Agreement are the terms of the revised EDR tariff sheets that KCP&L and GMO will submit to the

Commission once the tariff sheets for Tariff File Nos. JE-2014-0026 and JE-2014-0027 are withdrawn.

After reviewing the Stipulation and Agreement, the Commission finds it to be reasonable. The Commission determines it shall be approved.

## THE COMMISSION ORDERS THAT:

- The Stipulation and Agreement filed on September 27, 2013 is approved.
   A copy of the Agreement is attached as Attachment 1 and is incorporated as part of this order.
- Kansas City Power & Light Company, KCP&L Greater Missouri Operations
   Company, Staff of the Missouri Public Service Commission, and Office of the Public
   Counsel are ordered to comply with the terms of the agreement.
- 3. No later than October 21, 2013, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company shall file with the Commission a notice of withdrawal of the Tariff File Nos. JE-2014-0026 and JE 2014-0027 and file new tariff sheets that reflect the tariff sheets attached to the Stipulation and Agreement.
  - 4. This order shall become effective on October 13, 2013.
