ORDER APPROVING COMPLIANCE TARIFF

Issue Date: December 20, 2024

Effective Date: January 1, 2025

On November 21, 2024,¹ the Commission issued its *Order Approving Stipulation and Agreement* (Order) in the matter of a small utility rate case for Vicinity Energy Kansas City, Inc. (Vicinity). On December 3, Vicinity filed tariff sheets purporting to be in compliance with the Commission's Order. The tariff sheets, assigned Tracking No. JH-2025-0087, have an effective date of January 1, 2025.

The Staff of the Commission (Staff) reviewed the tariff sheets and provided its recommendation on December 18. Staff's recommendation was that the tariff sheets should be approved. No other responses to the compliance tariff sheets were received.

Upon reviewing the pleadings, the Commission finds Vicinity's proposed tariff sheets comply with the Commission's Order and will approve them. To accommodate Vicinity's chosen tariff effective date which was approved by the Commission in the Order, the Commission will make this order effective in less than thirty days and will approve the proposed tariff sheets to become effective on January 1, 2025.
