# ORDER DIRECTING RESPONSES

Issue Date: December 20, 2024 Effective Date: December 20, 2024

On December 20, 2024,<sup>1</sup> the Commission issued its *Order Setting Procedural Schedule* (Order). Later on the same date, the Office of the Public Counsel (OPC) filed *Public Counsel's Motion to Correct/Clarify Procedural Schedule* (Motion).

The Motion states that the parties agreed to use calendar days regarding the response time for data requests subsequent to June 23, but that the parties' submitted *Joint Proposed Procedural Schedule* (Joint Schedule) errantly stated business days.

The Motion states that the language itself is internally inconsistent as it refers first to business days, and later to calendar days. The language in the Order is substantially the same as the language in the Joint Schedule, and is as follows:

After the filing of Surrebuttal testimony (June 23, 2025), the response time for data requests shall be five **business days** to provide the requested information, and two business days to object or notify that more than five calendar days will be needed to provide the requested information. (emphasis added)

The Motion seeks to change the first instance of "business days" to "calendar

days". The Commission will direct the parties to respond to OPC's Motion.
