ORDER APPROVING TARIFF

On December 16, 2024, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed the above-reference tariff. Evergy Missouri West filed the tariff to implement new rates as permitted by the Commission's December 4, 2024 Report and Order. That Report and Order approved stipulations, which, among other things, allowed Evergy Missouri West to file a compliance tariff bearing an effective date of January 1, 2025.

The Commission's Staff filed a Recommendation on December 20, 2024, stating that the Commission should approve the tariff. No other responses were received.

The Commission has reviewed the tariff and Staff's recommendation. Based on these filings, the Commission finds that the tariff complies with the Report and Order.

The Commission approves the tariff as ordered below. As the tariff is unopposed, and so that this tariff may go into effect expeditiously on the requested effective date, the Commission will make this order effective in less than thirty days.

1. Tracking No. JE-2025-0095, submitted on December 16, 2024, is approved to become effective on January 1, 2025.
