ORDER DIRECTING STAFF RESPONSE

Staffs memorandum supporting its recommendation asks that the Commission approve Confluence Rivers’ proposed monthly charge of \$21.00 for Confluence Rivers sewer service, and the rules governing sewer service currently located in Confluence Rivers sewer tariff P.S.C. Mo. No. 31. However, on page five of the joint application for the transfer of assets, the application states that “Confluence Rivers proposes to utilize the existing customer rates for United Services. Upon acquisition, Confluence Rivers would propose to serve these customers using its currently approved rules and terms of service as reflected in P.S.C. MO No. 31.” The current United Services (United Fiber) tariff P.S.C. MO No. 2, Sheet No. 16, states that its rates for sewer service are \$44.92 for residential customers and \$54.30 for commercial customers.

The Commission will direct its Staff to explain this inconsistency.

THE COMMISSION ORDERS THAT:

1. Staff shall explain the rate inconsistency between its recommendation and the requested rate in the joint application for the transfer of assets no later than December 30, 2024.

2. This order shall be effective when issued.
