Environmental Matters

We are subject to various federal, state, and local laws and regulations with respect to air and water quality and with respect to hazardous and toxic materials and hazardous and other wastes, including their identification, transportation, disposal, record-keeping and reporting, as well as remediation of contaminated sites and other environmental matters. We are also subject to requirements regulating the operation of renewable energy – hydro, solar and wind. While we are not in a position to accurately estimate compliance costs for any new requirements, we expect these costs to be material, although recoverable in rates.

<u>Compliance</u> Plan

The Company completes an IRP for the generation capacity build-out and replacement plans. Within this IRP, the Company selects a preferred plan that maintains compliance with the current environmental rules. The preferred IRP also balances customers' growing demand and interest in renewable energy, improved environmental performance, and distributed energy resources. Compliance costs we have incurred in previous plans associated with MATS, CSAPR and Missouri Renewable Energy Standard regulation are being recovered in our rates, and we anticipate any future costs to continue to be recoverable in our rates.
