ORDER CANCELING REGISTRATION

Issue Date: December 23, 2024

Effective Date: January 2, 2025

On November 20, 2024, Sangoma US Inc. d/b/a Star2Star Communications, LLC filed a letter seeking to cancel its registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the State of Missouri. The Commission granted Star2Star Communications, LLC its IVoIP registration in the State of Missouri in File No. DA-2018-0246.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Star2Star Communications, LLC's request, the Commission finds that the IVoIP registration granted to Star2Star Communications, LLC shall be canceled.

IT IS ORDERED THAT:

1. The registration to provide Interconnected Voice over Internet Protocol services, granted to Star2Star Communications, LLC in File Number DA-2018-0246, is canceled.
2. This order shall become effective on January 2, 2025.
3. This case may be closed on January 3, 2025.
