**STAFF RECOMMENDATION TO APPROVE TARIFFS**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its recommendation that the Commission approve the tariff sheets filed by Holtgrewe Farms Water Company, LLC and Holtgrewe Farms Sewer Company, LLC, states the following:

1. On December 2, 2024, Holtgrewe Farms Water Company, LLC and Holtgrewe Farms Sewer Company, LLC filed tariffs in the above captioned cases which were assigned Tracking No. JW-2025-0083 and JS-2025-0084, respectively. The tariffs carry an effective date of January 9, 2025.

2. On December 3, 2024, the Commission issued its *Order Directing Responses to Compliance Tariff*. The *Order* directed Staff to file a recommendation as to whether the tariffs comply with the disposition agreement no later December 26, 2024.

3. Staff has reviewed the tariffs and found that they comply with the disposition agreement and recommends that they be approved.

**WHEREFORE**, Staff respectfully submits this Staff Recommendation to Approve Tariffs, and respectfully requests the Commission approve the tariffs filed by Holtgrewe Water Company, LLC and Holtgrewe Sewer Company, LLC.


