ORDER GRANTING VARIANCE AND EXTENSION TO FILE STAFF RECOMMENDATION

On November 27, 2024, Union Electric Company d/b/a Ameren Missouri filed a tariff sheet, with supporting testimony, to adjust the rate of its Missouri Energy Efficiency Investment Act (MEEIA) Energy Efficiency Investment Charge (EEIC). The tariff sheet bears an effective date of February 1, 2025.

On December 2, 2024, the Commission directed its Staff to file a recommendation regarding Ameren Missouri's proposed adjustments no later than December 27, 2024.

On December 24, 2024, Staff filed a *Motion for Variance and Extension of Time to File Staff Recommendation*. Staff requests additional time to review the proposed adjustments and supporting documentation provided by Ameren Missouri, citing the time required by the current schedule for all matters pending before the Commission.

Commission Rule 20 CSR 4240-20.093(4)(B) requires Staff to examine and analyze the information filed by Ameren Missouri and to submit a recommendation no later than 30 days after Ameren Missouri's tariff filing. However, under Commission Rule 20 CSR 4240-20.093(14), the Commission may grant a variance from any provision of the rule upon request and for good cause shown.

The Commission finds there is good cause shown to grant a variance from Commission Rule 20 CSR 4240-20.093(4)(B) and will do so in granting Staff's motion. However, the Commission will shorten the extension period requested.¹

THE COMMISSION ORDERS THAT:

1. Staff's motion is granted.
2. Staff is granted a variance from the requirement of Commission Rule 20 CSR 4240-20.093(4)(B) to examine and analyze the information filed by Ameren Missouri and to submit a recommendation no later than 30 days after Ameren Missouri's tariff filing.
3. Staff shall file a recommendation on Ameren Missouri's tariff sheet adjusting its MEEIA EEIC no later than January 13, 2025.
4. This order shall be effective when issued.
