On November 25, 2024,¹ Spire Missouri Inc. d/b/a Spire filed tariff sheets and testimony initiating a rate case to increase its annual water and sewer revenues. Missouri School Board Association (MSBA), Midwest Energy Consumers Group (MECG) and Missouri Industrial Energy Consumers (MIEC) filed timely applications to intervene. Ten days have elapsed, and no party has objected to the application to intervene.² The application satisfy the requirements of Commission Rule 20 CSR 4240-2.075 and intervention will be granted.

THE COMMISSION ORDERS THAT:

1. MSBA's application to intervene is granted.
2. MECG's application to intervene is granted.
3. MIEC's application to intervene is granted.
4. This order shall be effective when issued.
