**ORDER GRANTING MOTION FOR VARIANCE AND EXTENSION OF  
TIME TO FILE STAFF RECOMMENDATION**

On December 24, 2024, the Staff of the Commission (Staff) filed a Motion for Variance and Extension of Time to File Staff Recommendation in these cases. Staff explains that due to recent substitute tariff filings in these cases, it cannot file its Staff Recommendation by January 2, 2025. Staff requests a variance under Commission Rule 20 CSR 4240-20.093(14) to allow Staff to provide a recommendation no later than January 17, 2025, which is beyond the 30-day timeframe outlined under Commission Rule 20 CSR 4240-20.093(4)(B).

Staff has stated good cause for a variance from Commission Rule 20 CSR 4240-20.093(4)(B). Thus, the Commission will grant a variance from the rule, and will grant Staff an extension of time to file its Recommendation.

**THE COMMISSION ORDERS THAT:**

1. Staff's request for a variance from Commission Rule 20 CSR 4240-20.093(4)(B) is granted.
2. The Staff of the Commission shall file its recommendation no later than January 17, 2025.
3. This order shall be effective when issued.
