## ORDER APPROVING COMPLIANCE TARIFFS

Issue Date: December 27, 2024

Effective Date: January 9, 2025

On December 11, 2024,<sup>1</sup> the Commission issued its *Order Approving Disposition Agreement* (Order) in the matter of a small utility rate case for Holtgrewe Farms Water Company, LLC (Holtgrewe Water) and Holtgrewe Farms Sewer Company, LLC (Holtgrewe Sewer).

On December 2, Holtgrewe Water and Holtgrewe Sewer filed tariffs in the above captioned cases which were assigned Tracking Nos. JW-2025-0083 and JS-2025-0084, respectively. The tariffs bear an effective date of January 9, 2025.

The Staff of the Commission (Staff) reviewed the tariff sheets and provided its recommendation on December 24. Staff's recommendation was that the tariff sheets should be approved. No other responses to the compliance tariff sheets were received.

Upon reviewing the pleadings, the Commission finds the proposed tariff sheets comply with the Commission's Order and will approve them. To accommodate the chosen

tariff effective date, the Commission will make this order effective in less than thirty days and will approve the proposed tariff sheets to become effective on January 9, 2025.

1. The proposed tariff sheets filed on December 2, and assigned Tracking Nos. JW-2025-0083 and JS-2025-0084, are approved to become effective on January 9, 2025.
