On October 18, 2024, Union Electric Company d/b/a Ameren Missouri filed the above-referenced application. Ameren Missouri wishes to own, operate, maintain, and otherwise control and manage a new substation, and to reconfigure an existing transmission substation, in Cooper County, Missouri. The Commission granted intervention to certain parties, and ordered the parties to file a proposed procedural schedule or a status report no later than December 27, 2024.

On December 27, 2024, the parties filed a Status Report. The parties state that Staff needs additional time to evaluate its position on the application. They further state that they would like an additional 30 days to decide if a hearing is needed.

The Commission finds the parties' request for an additional 30 days reasonable, and will grant it.

- 1. The parties shall file a proposed procedural schedule or an alternative pleading no later than January 27, 2025.
