# ORDER DIRECTING THE PARTIES TO PROVIDE AVAILABILITY FOR A WEBEX PREHEARING CONFERENCE

On November 26, 2024, Grain Belt Express, LLC (Grain Belt) filed a request for a protective order to protect specific highly confidential information from disclosure. The Commission received no timely responses to Grain Belt's request and subsequently granted the protective order. On December 30, 2024, Complainant, Cheri Meadows, contacted the Commission's Data Center to inquire how she might access Grain Belt's highly confidential protected information.

The Regulatory Law Judge would like to have a prehearing conference to discuss the relevance of the highly confidential information to this complaint and whether the information should be released to Complainant, and under what conditions.

The Commission will direct the parties to supply their availability for a WebEx prehearing conference between January 6, 2025 to January 10, 2025.

- 1. No later than January 2, 2025, the parties shall provide their availability from January 6, 2025 to January 10, 2025, for a WebEx prehearing conference.
