ORDER CANCELING REGISTRATION

Issue Date: December 31, 2024

Effective Date: January 10, 2025

On December 11, 2024, Aristotle Unified Communications, LLC filed a letter seeking to cancel its registration to provide Interconnected Voice over Internet Protocol service (“IVoIP”) in the State of Missouri. The Commission granted VoIP Innovations, LLC its IVoIP registration in the State of Missouri in File No. DN-2024-0210.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Aristotle Unified Communications, LLC’s request, the Commission finds that the IVoIP registration granted to Aristotle Unified Communications, LLC shall be canceled.

IT IS ORDERED THAT:

1. The registration to provide Interconnected Voice over Internet Protocol services, granted to Aristotle Unified Communications, LLC in File Number DN-2024-0210, is canceled.
2. This order shall become effective on January 10, 2025.
