STAFF RECOMMENDATION TO APPROVE TARIFFS

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and files its *Staff Recommendation to Approve Tariff Sheets*, and states the following in support:

- 1. On July 18, 2024, the Commission issued an *Order Approving Stipulation and Agreement Regarding Carbon Offset Initiative* ("*Order*"), and the Commission reiterated that the originally filed tariff sheets were suspended until October 27, 2024. The Commission further authorized Spire Missouri Inc. d/b/a Spire ("Spire Missouri") to file tariff sheets that are in compliance with the Stipulation and Agreement.
- 2. On July 30, 2024, counsel for Spire sent an email to the presiding judge and the other parties indicating Spire Missouri would not file tariff sheets to implement the program until Spire Missouri determined and exact date of the program implementation.
- 3. On October 2, 2024, in order to prevent the original tariff sheets filed on November 29, 2023, from becoming effective on October 27, 2024, the Commission issued an Order rejecting the tariff sheets filed by Spire Missouri under assigned Tracking No. JG-2024-0073.

- 4. On December 17, 2024, Spire Missouri filed its revised tariff sheets under JG-2025-0097, along with its accompanying tariff filing letter. In its letter, Spire Missouri stated the tariff sheets were intended to reflect the Commission's Order Approving the Stipulation and Agreement Regarding the Carbon Offset Initiative.
- 5. On December 18, 2024, the Commission issued an *Order Directing*Staff Recommendation on Compliance Tariff Sheets. The Commission ordered Staff to file a recommendation regarding the compliance tariffs no later than January 3, 2025.
- 6. Staff has reviewed the tariff sheets filed in Tariff Tracking No. JG-2025-0097 on December 17, 2024. Staff recommends the Commission approve the tariff sheets as filed on December 17, 2024, with effective dates of January 18, 2025.
- 7. This pleading is verified by the affidavits of Matthew Lucas and Marina Stever, which are incorporated by reference herein.

WHEREFORE, for the reasons stated above, Staff recommends the Commission issue an order approving the following tariff sheets filed in this matter, Tariff Tracking No. JG-2025-0097, on December 17, 2024, with an effective date of no later than January 18, 2025:
