ORDER APPROVING TARIFF

By Order issued on July 7, 1998, the Commission granted to Green Hills Area Cellular Telephone Company, Inc. d/b/a Green Hills Telecommunications Services (GHTS) a certificate of service authority to provide basic local telecommunications services in Missouri. The Order waived the filing of a 45-day tariff as required by 4 CSR 240-2.060(4)(H) until 30 days after GHTS entered into a Commission-approved interconnection agreement to enable it to provide basic local exchange services. GHTS' certificate of service authority will become effective upon the effective date of its approved tariffs. GHTS' interconnection agreement with GTE Midwest Incorporated and GTE Arkansas Incorporated (GTE) was approved by the Commission on September 22, in Case No. TO-98-582. GHTS' interconnection agreement with Sprint Missouri, Inc. was approved by the Commission on November 17, in Case No. TO-99-75. GHTS filed tariff sheets on December 11, with an effective date of January 10, 1999. The tariff sheets outline the rates, rules,

regulations and services that GHTS will provide. GHTS filed substitute tariff sheets on December 18.

The Commission's Staff reviewed the tariff sheets and filed a memorandum on December 28 recommending that the Commission approve them as amended by the substitute sheets. Staff's memorandum indicates that GHTS' proposed tariff is similar to other competitive local exchange company (CLEC) tariffs previously approved by the Commission. GHTS proposes to charge a monthly rate of \$6.50 and \$13.00 respectively, for residential and business basic local exchange service. This rate includes access to local operator services, touch-tone dialing and a basic local exchange calling scope. GHTS proposes to offer intra and interLATA presubscription to its basic local service subscribers. Other services being proposed include Custom Calling Services such as call waiting, Custom Local Area Signaling (CLASS) services such as caller identification, and 900 blocking service that is available at no charge to customers. Staff recommended that the tariff be approved as amended to become effective on January 10.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets, as amended, conform to the Commission's Order of July 7 and should be approved to become effective on January 10. The Commission concludes that the conditions stated in the July 7 order granting GHTS certificate of service authority to provide basic local telecommunications service have been satisfied and the certificate will take affect on January 10.

IT IS THEREFORE ORDERED:


1. That the tariff filed by Green Hills Area Cellular Telephone Company, Inc. d/b/a Green Hills Telecommunications Services on December 11, 1998, and assigned tariff number 9900451, is approved as amended to become effective on January 10, 1999. The tariff approved is:

2. That the certificate of service authority granted to Green Hills Area Cellular Telephone Company, Inc. d/b/a Green Hills Telecommunications Services on July 7, 1998, to provide local exchange telecommunications services shall become effective on January 10, 1999.

3. That this order shall become effective on January 10, 1999.
