**ORDER DENYING MOTION FOR REHEARING
OR RECONSIDERATION**

On November 6, 2019, the Missouri Public Service Commission issued a *Report and Order*, effective December 6, 2019, regarding KCPL's² prudence in allowing its renewable energy credits to expire; GMO's³ prudence in allocating costs associated with auxiliary power; and GMO and KCPL's prudence in entering into purchase power agreements with the Rock Creek and Osborn Wind projects. On December 5, 2019, the Office of Public Counsel (OPC) filed a *Motion for Rehearing or Reconsideration*.

Section 386.500.1, RSMo 2016, states that the Commission shall grant an application for rehearing if "in its judgment sufficient reason therefor be made to appear." In the judgment of the Commission OPC's motion does not demonstrate sufficient reason to reconsider or rehear the matter. The Commission will deny the *Motion for Rehearing or Reconsideration*.
